DRAFT GUIDELINES ON THE SETTING UP OF COMMITTEES TO FIGHT AGAINST GENDER-BASED VIOLENCE AND FOR THE PROTECTION OF CHILD'S RIGHTS, FROM UMUDUGUDU TO DISTRICT LEVELS

Following various consultative meetings among stakeholders and partners involved in the above area, it has been agreed to set up one set of committees to fight against genderbased violence and to protect the Rights of the Child from Umudugudu to levels and to include elements of responsibilities at the national level as well.

The protection against violence, whatever violence, is each and everybody's responsibility, in order to safeguard human rights of children, women and men.

It has been the expressed wish by MIGEPROF and its partners (including the decentralized authorities) at various meetings that these committees be established in every District.

The proposed guidelines include the followings

- 1. The composition of the Committees from the Umudugudu to the national levels
- 2. The specific tasks assigned to these Committees at each level
- 3. The prerequisites for the Committees to meet their obligations
- 4. The structure and the coordination mechanisms

3. THE PREREQUISITES FOR THE COMMITTEES TO OPERATE

For the Committees to be able to meet their obligations, the followings are the prerequisites:

- The training for the members at all levels
- The establishment of a fund to support the most vulnerable among the victims (a task for Sectors and Districts)
- An annual plan of action in fighting the GBV and in the protection of the Rights of the Child for each Committee
- A basic set of tools such as training materials, brochures outlining the laws and regulations in the two domains, a budget, transportation facilities provided by the Police at Sector or District level for emergency evacuation of victims such as victims of rapes for immediate HIV preventive measures.
- Other things the Committees may occasionally need

4. STRUCTURE & COORDINATION MECHANISMS

4.1 The structure

The Committees are made up of persons who are dedicated to the cause of the population, are prepared to cooperate in fighting against gender-based violence and the violation of the Rights of the Child, and are eager to assist victims and advocate on their behalf

For the Committees to be able to meet their obligations they must have their own internal regulations, an action plan about their meetings, elect a bureau of three people (Chairman, vice Chair, and Secretary), and to report one level to the immediate upper one at least every month.

4.2. Coordination and Reporting

- MIGEPROF has the overall responsibility to coordinate all the activities related to fighting against GBV and protecting child's rights
- MINALOC should ensure that each District will include a report on the situation concerning the fight against GBV and for the protection of child's rights in its performance contracts and illustrate this with numbers
- Study tours and discussion forums should be organized for exchange of ideas and experiences among the district in order to make known the best practices or results. The case of the district of GATSIBO is an illustration
- There should be, at national level, semi-annual reviews on the progress in fighting against GBV and for the protection of child's rights in all the districts
- Committees should meet at least monthly at Imidugudu and Cells levels, every three months at Sector and District levels with, each time, a report to the immediate upper level.
