The use of Information Communication Technology (ICT) in Justice Sector has proven to accelerate information dissemination, improve efficiency of Justice Sector services, increase the transparency and accountability of justice Sector administration and facilitate citizen participation in the provision of justice related services. It has greatly contributed to the transformation of justice sector operation by introducing new ways of internal operation as well as how justice sector delivers services to the people of Rwanda.
