Two stage- tendering for design the Unity and Reconciliation Monument.

The National Unity and Reconciliation Commission invite the individual artistes to submit their initial bid based on their proposals relating to the technical aspect, without a tender price.

1. Background and context

The general mandate of National Unity and Reconciliation Commission is to promote unity and reconciliation among Rwandans. The promotion of national unity and reconciliation in Rwanda has become a cornerstone to all national efforts and a basis for combating all forms of discrimination and exclusion that have characterized the Rwandans in the past. It is the only option to survival for Rwanda that is emerging from a divided past, genocide and moving towards a reconciled and democratic nation.

Twenty three years have elapsed after Rwanda has embarked on the process toward reconciliation and the restoration of unity, since the end of the 1994 genocide perpetrated against Tutsi.

Unity of Rwandans existed in the past prior to colonization. It was later negatively affected by divisions created by colonial administration and later entrenched by the two successive republics that came to power after independence. To address this dark past of Rwanda, towards a new and bright society, the restoration of national unity and reconciliation was thus vital.

The necessity of restoring national unity and reconciling Rwandans was materialized in the establishment of the National Unity and Reconciliation Commission. Other mechanisms have been also put in place, which focuses on the experience of Rwanda with regard to how Rwanda engaged in the restoration of unity and reconciliation.

It is in this regard that the National Unity and Reconciliation Commission require consulting services by a competent and experienced individual artistes—for the design of the Unity and Reconciliation Monument as symbol of achievements and valuable efforts of Rwandans in the process of unity and reconciliation.

2. Objective of the assignment

To materialize efforts made in reconstruction of unity and reconciliation of Rwandans and to have a symbol of Hope, Peace and Reconciliation.

3. The assignment shall cover the following:

Eligible individual artistes are invited to:

- 1. Develop in details, different steps of the design of Unity and Reconciliation Monument;
- 2. Propose architectural and components of the monument;
- 3. Detail explanatory notes of intervention in terms of architecture, construction, monument sculpture, size and material of construction;
- 4. Submit the methodology and plan for the construction of the monument and time frame (process of design and construction-approximately time for the process of design and construction).

The National Unity and Reconciliation Commission now invites capable individual artistes to indicate their interest in providing the technical aspect without a tender price, the information indicating that they are qualified to perform the services through detailed CVs (description of similar assignment, experience in similar work and availability of appropriate skills among staff).

The proposal must be in English or French.
